 - Curtis has created a Facebook page and group, an Instagram page, and a YouTube channel. The YouTube channel is NFH Alliance. Members may post other educational videos.
- Promoting the NFHA:
 - o Monthly drawings for members joining in the prior month are in process.
 - The Fjord Alliance Founding Member stemless wine glass fundraiser was a success earning \$3600 on donations. Wine glasses were donated by members Margaret Bogie, Sandi Pepper and Christine Hurst.
 - o Constant Contact emails are going out to members and other interested persons who have signed up to receive them.
 - The Fjord Alliance online store is being organized by Lee Hardin. Look for embroidered logo wear to be available soon. A portion of all purchases is donated to the Fjord Alliance.
 - o Janellen Cederstom, a retired association development officer, is spearheading the creation of a fundraising plan.
 - Curtis reported that the NFHA was promoted at the Pennsylvania Horse World Expo in Harrisburg, PA, this past weekend, Feb 29 – Mar 3. The NFHA will also have a presence at an expo in Berryville, VA, March 16 &

- 17, Equine Affaire in Columbus, OH, on April 11-14, and an expo in Herndon, VA, on April 13.
- Database for Farm and Stallion Directories: Curtis is working on creating the database and form interface which will be free for members.
- NFHA Committees: Thank you for the response to our poll for volunteers. We are 100 percent volunteer governed and managed. Consider volunteering and making a difference. Please contact an officer about volunteering.
- Videos: The 4 evaluation videos that were originally created by the NFHR became available because the NFHR decided to withdraw from the Virginia Horse Industry Board (VHIB) grant. - New VHIB Grants: Margaret is writing a grant proposal.
- Fjord Horse International (FjHI): Curt will research if the NFHA can join the FjHI. Later in the meeting a member passed on that the FjHI rules changed a couple years ago. There can be more than one member per country.
- Awards Program: A committee has been formed and the program is being developed.
 - USDF All-Breed Awards program is available to Fjord Alliance members.

 - Pony Cup year end high score awards for Fjords is being sponsored by the Fjord Alliance in Open, Amateur and Junior levels. See dressageponycup.com for more information.

 - Year-end awards in other disciplines and in non-competitive activities are being created. They will be announced as they become available.
